With over 70 years of experience, the company operates 12 manufacturing facilities and serves customers across 48+ countries. Supported by strategic global acquisitions and strong engineering capabilities, WPIL continues to strengthen its leadership in industrial pumping solutions and large-scale water infrastructure projects.

2 Business Segments (Q1-FY27)

Products Segment (48%): WPIL operates 12 facilities across four continents, including a captive foundry, ensuring quality, cost efficiency, and reliable global supply. Supported by advanced testing infrastructure and in-house R&D, it delivers high-performance pump solutions globally. Its strengths span vertical turbine pumps, horizontal pumps for water and steel, large cooling-water systems, utility pumps for oil & gas, and firewater pumps. The company targets 20% annual product growth over the next five years, driven by export-led expansion, international platforms, operating leverage, and mix improvement.

Projects Segment: EPC and O&M (52%): The Project division delivers end-to-end turnkey water and infrastructure solutions, covering surveys, design, intake structures, treatment plants, pumping stations, pipelines, and last-mile connectivity. Backed by in-house civil, electrical, mechanical, and design engineering teams, it executes fully integrated large-scale systems. The division focuses on municipal water and wastewater (primary), irrigation, and industrial sectors such as power and steel. With expanding international presence through Eigenbau, PCI Africa, and MISA Italia, its backlog is increasingly export-led, strengthening overseas execution visibility.

- Technology-led growth through strategic acquisitions enhancing product portfolio and market access.

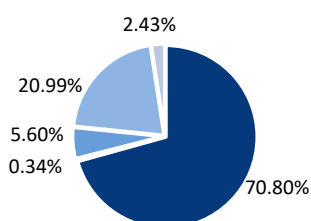
4 Key Growth Drivers
